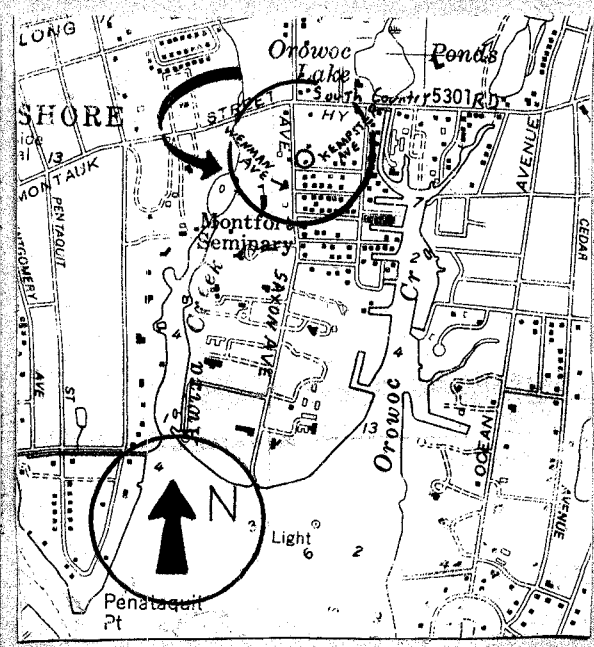

15 Saxon Avenue is located on the east side of the road at the NE corner of Kempster Avenue. Four similiar houses stand southward along the east side of the street. Predominantly open land directly west.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

15 Saxon Avenue is a 2½ story, three bay, hip roof, stucco house. A triple window band at the center of the second story is set directly below a semi-octagonal dormer on the west roof slope. The small corner lot is surrounded by a low privet hedge.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:

This Arts & Crafts style house is one of five similiar houses on the east side of Saxon Avenue that apparently were built by Wm. H. Moffitt, perhaps for summer rentals. Bay Shore was a popular summer resort in the early years of the 20th century. This small area was called Olympic Park in 1915.
