

70 Years Ago

At a joint meeting of the Town Board and Highway Commissioners, Supervisor Hauser suggested that the people of Islip Town should send in a petition for a slice of the \$50,000 appropriation for new roads. The sentiment of the meeting seemed to be that shell roads properly kept up were as good as macadam and that it would be better if the highways were built of native material.

Sheriff John S. Wells had taken office on the first of the year. Isaac Bedell of Sayville was appointed a deputy and William T. Hayward, a popular summer resident of Sayville, was appointed a special deputy sheriff for the purpose of enforcing the automobile speed law.

Miss Ruth N. Smith of Patchogue, a public spirited woman of considerable local fame, had just erected a large statue in her own likeness, a monument to herself.

Seed oysters, according to an item from Port Jefferson, had dropped from 30 to 10 cents a bushel.

60 Years Ago 1915

After having been in the courts since the spring of 1914 the actions of Commodore Frederick G. Bourne and Florence Bourne vs. the Bluepoints Co. to compel the removal of the large oyster house at the foot of West Street in West Sayville were still awaiting final disposition.
